### MINUTES OF THE MAYOR AND COUNCIL

**January 27, 2026**

**PRESENT:** Mayor John Coiro, presiding, Council President Lou D'Angelo, Councilman Anthony Picarelli, Councilman William Bucher, Councilman Patrick Fierro, Councilman Sanders Reynoso, Councilwoman Kristen Coiro, Municipal Clerk Joseph Wassel and Municipal Attorney Kristin Corrado.

**ABSENT:** None.

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

Municipal Clerk Wassel read the following statement: This meeting of the Mayor and Council held on this day is being held in accordance with Chapter 231, P.L. 1975 of the State of New Jersey as amended. The agenda for this meeting has been prepared and distributed to the Mayor and Council and a copy has been on file in the Office of the Municipal Clerk.

There was a motion by Councilman D'Angelo, seconded by Councilman Picarelli to dispense with the regular order of business in order to hold a public hearing on Ordinance No. 01-2026 as advertised. On roll call vote, all members of the Council present voted in the affirmative.

Municipal Clerk Wassel announced that Ordinance No. 01-2026 has been advertised for public hearing for Tuesday, January 27, 2026.

Municipal Clerk Wassel read the legal notice and the title of Ordinance No. 01-2026.

There was a motion by Councilman D'Angelo, seconded by Councilman Picarelli to open the public hearing. On roll call vote, all members of the Council present voted in the affirmative.

There was a motion by Councilman D'Angelo, seconded by Councilman Picarelli to adopt Ordinance No. 01-2026 on second and final reading. On roll call vote, all members of the Council present voted in the affirmative.

Councilman Reynoso: 1) Thanked the DPW for their efforts with the snowstorm and Board of Recreation Director Mark Monteyne who organized a group of "angels" to assist our senior citizens with shoveling their properties; 2) Announced that we will be having Blood Drives on February 5<sup>th</sup> and April 3<sup>rd</sup>; the Car Show on April 26<sup>th</sup>; and Totowa Day on June 13<sup>th</sup>.

Mayor Coiro: Thanked our DPW, Police, Fire, EMT's and our "snow angels" for all of their efforts during our recent snowstorm. Also, remarked that Marlon Alexander the owner of Hillery Street Restaurant & Grill opened for business during the snowstorm just to feed our DPW workers and Police and said he will be sending him a thank you letter.

WHEREAS, by Resolution No. 33-2024 dated February 13, 2024, the Mayor and Council of the Borough of Totowa authorized the purchase and installation of a dash cam system to be installed in each of the fleet patrol vehicles; and

WHEREAS, more specifically, pursuant to State of New Jersey Contract No. 17-Fleet-00738, the Mayor and Council of the Borough of Totowa authorized the purchase and installation of a Fleet 3 Advanced dash cam system from Axon Enterprises, Inc., 17800 North 85<sup>th</sup> Street, Scottsdale, Arizona 85255 in the amount of \$109,919.40; and

WHEREAS, the Resolution also required that Axon Enterprises, Inc. provide all integration and support services for a 5-year period effective January 1, 2024 through December 31, 2028 and that payments for the Fleet 3 Advanced dash cam system would be made in installments over the 5-year period; and

WHEREAS, Axon Enterprises, Inc. has submitted the invoice for the 2026 installment in the amount of \$21,950.10, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, Mayor and Council of the Borough of Totowa desire to authorize the 2026 installment payment for the dash cam system to Axon Enterprises, Inc.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the installment payment for the Fleet 3 Advanced dash cam system to Axon Enterprises, Inc. in the amount of \$21,950.10.

BE IT FURTHER RESOLVED, that the Mayor and Municipal Council of the Borough of Totowa do hereby authorize the Municipal Clerk and Acting Police Chief to execute any and all instruments relating thereto.

WHEREAS, the boiler at the Borough of Totowa Municipal Complex is not working properly and is in need of various repairs; and

WHEREAS, 454 Mechanical, LLC, 14 Masklee Court, Totowa, New Jersey 07512 has submitted a proposal dated January 5, 2026 for the Boiler #1 – Circulator Pump Replacement for the sum of \$5,165.00, a copy of which is on file in the office of Borough of Totowa Municipal Clerk; and

WHEREAS, the proposal includes bleeding and purging the system, starting and testing the system and includes all necessary labor and materials needed to complete the Boiler #1 – Circulator Pump Replacement; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to have the boiler repair undertaken and completed as soon as possible for the well-being of the employees and members of the community that work in and visit the Borough of Totowa Municipal Complex; and

WHEREAS, pursuant to the applicable New Jersey State laws, the repair services may be authorized without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by 454 Mechanical, LLC for the Boiler #1 – Circulator Pump Replacement at the Borough of Totowa Municipal Complex.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize 454 Mechanical, LLC to perform all services for the Boiler #1 – Circulator Pump Replacement at the Borough of Totowa Municipal Complex in accordance with their proposal.

RESOLUTION AUTHORIZING EMERGENCY REPAIRS  
AT THE LACKAWANNA PUMP STATION

WHEREAS, the Borough of Totowa Department of Public Works ("DPW") Superintendent had advised the Mayor and Council of the Borough of Totowa that Pump #2 at the Lackawanna Pump Station was no longer working satisfactorily and needed to be replaced as soon as possible; and

WHEREAS, the Pump Station services the residents of the Borough of Totowa by collecting sanitary sewerage waste from individual users throughout the municipality where it is processed and conveyed to the Passaic Valley Sewerage Commissioners located in Newark, New Jersey for proper treatment and disposal; and

WHEREAS, the Borough of Totowa DPW Superintendent had recommended that the Borough of Totowa remove the existing Pump and replace it with an existing spare Pump; and

WHEREAS, the DPW was able to dismantle the existing Pump in anticipation of replacing it with the spare Pump that was on hand for such emergencies; and

WHEREAS, North Jersey Wastewater Cooperative Pricing System Contract No. B454-20 has been awarded to Integrated Power Services, 18 Sebago Street, Clifton, New Jersey 07013 for the repair, replacement and/or installation of pumps and related equipment; and

WHEREAS, Integrated Power Services submitted a proposal dated December 17, 2025 for the installation of the Pump in the amount of \$6,885.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, the proposal included transporting the original Pump back to their facility for evaluation and possible rebuild; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize these necessary repairs for the Lackawanna Pump Station for the general health, safety and well-being of the residents of the Borough of Totowa; and

WHEREAS, pursuant to Local Public Contracts Law, the emergency repair of Pump #2 at the Lackawanna Pump Station may be authorized by the Borough of Totowa without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by Integrated Power Services for the emergency repair of Pump #2 at the Lackawanna Pump Station in the amount of \$6,885.00.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize Integrated Power Services to provide the labor and materials for the emergency repair of Pump #2 at the Lackawanna Pump Station as set forth in their proposal.

WHEREAS, the Borough of Totowa Department of Public Works ("DPW") Superintendent has advised the Mayor and Council of the Borough of Totowa that the Pumps for the South End Pump Station are no longer working satisfactorily and must be repaired as soon as possible; and

WHEREAS, the Pump Station services the residents of the Borough of Totowa by collecting sanitary sewerage waste from individual users throughout the municipality where it is processed and conveyed to the Passaic Valley Sewerage Commissioners located in Newark, New Jersey for proper treatment and disposal; and

WHEREAS, the Borough of Totowa DPW Superintendent has recommended that the existing Pumps be replaced and a new back-up system be installed; and

WHEREAS, North Jersey Wastewater Cooperative Pricing System Contract No. B454-20 has been awarded to Integrated Power Services, 18 Sebago Street, Clifton, New Jersey 07013 for the repair, replacement and/or installation of pumps and related equipment; and

WHEREAS, Integrated Power Services has submitted a proposal dated November 12, 2025 for the replacement of two Pumps and installation of a new back-up system in the amount of \$19,930.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize these necessary repairs for the South End Pump Station for the general health, safety and well-being of the residents of the Borough of Totowa; and

WHEREAS, pursuant to Local Public Contracts Law, the replacement of the Pumps and installation of a new back-up system at the South End Pump Station may be authorized by the Borough of Totowa without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by Integrated Power Services for the replacement of the Pumps and installation of a new back-up system for the South End Pump Station in the amount of \$19,930.00.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize Integrated Power Services to provide the labor and materials for the replacement of the Pumps and installation of a new back-up system for the South End Pump Station.

A letter was received from the Totowa Public Library and Library Foundation requesting permission to use the Municipal Parking Lot for a Borough Wide Garage Sale to include a Household Goods & Clothing Collection, a Shredding Event and Eyeglass and Hearing Aid Collection, along with a Food Drive sponsored by Senator Kristin Corrado on Saturday, April 25, 2026. #### RESOLUTION APPOINTING AN AFFORDABLE HOUSING PLANNER FOR THE BOROUGH OF TOTOWA

WHEREAS, on March 20, 2024, Governor Murphy signed a Bill into law (P.L. 2024, c. 2) that radically revised the New Jersey Fair Housing Act (“FHA”); and

WHEREAS, the revised FHA abolishes the Council on Affordable Housing (“COAH”) and purports to reform municipal responsibilities concerning the provision of affordable housing; and

WHEREAS, the revised FHA includes many other provisions and changes to the FHA that are impractical and devoid of any consideration of the burdens created by the statute; and

WHEREAS, the Borough of Totowa requires the services of a licensed Planning Professional who can assist with the new affordable housing mandates; and

WHEREAS, the Mayor and Council of the Borough of Totowa did advertise for receipt of sealed proposals for the professional planning services in accordance with its specifications entitled "Request for Proposals for the Position of Municipal Planner for the Borough of Totowa"; and

WHEREAS, the Borough of Totowa did receive proposals at its Municipal Building on December 19, 2025; and

WHEREAS, the Liaison and Inspection Committee did examine all proposals for professional planning services; and

WHEREAS, Robert Hudak, MPA, PP, AICP, InSite Engineering, LLC, 1955 Route 34, Suite 1A, Wall, New Jersey 07719 has submitted a proposal dated December 17, 2025 to provide the professional planning services, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk, and

WHEREAS, the firm of InSite Engineering, LLC possesses the necessary experience and expertise to perform the professional planning services; and

WHEREAS, for providing the required services, the Borough of Totowa will compensate, InSite Engineering, LLC in accordance with their proposal; and

WHEREAS, the term of this contract shall be for a period of one year effective as of the date of this Resolution and terminating on December 31, 2026; and

WHEREAS, the professional planning services shall be awarded as a fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 et seq

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the Borough of Totowa to enter into a contract with InSite Engineering, LLC to serve as the Borough of Totowa Affordable Housing Planner and provide professional planning services.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.
