# MINUTES OF THE MAYOR AND COUNCIL

# February 14, 2023

PRESENT: Mayor John Coiro, presiding, Council President Lou D'Angelo,

Councilwoman Debra Andriani, Councilman Anthony Picarelli, Councilman William Bucher, Councilman John Capo, Councilman Patrick Fierro, Municipal Clerk Joseph Wassel and Municipal Attorney Kristin Corrado.

**ABSENT:** None.

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

Municipal Clerk Wassel read the following statement: This meeting of the Mayor and Council held on this day is being held in accordance with Chapter 231, P.L. 1975 of the State of New Jersey as amended. Councilman D'Angelo: Wished Councilwoman Andriani a Happy Birthday.

#### CITIZENS HEARD:

<u>Carla Grant, 88 Grant Avenue</u>: Said that she lives down the street from the building that was constructed on the corner of Grant Avenue and Totowa Road and that it's a safety hazard because you can't see when you have to make a left or right turn onto Totowa

Road. <u>Mayor Coiro</u>: Asked Project Manager John Waryas to bring Construction Code Official Allan Burghardt to the site to make sure that the building was constructed according to their approvals and to report back.

WHEREAS, the Mayor and Council of the Borough of Totowa wishes to apply for funding of approximately \$32,400 with a match of \$445,928 for an approximate project total cost of \$478,328 for a project under the State of New Jersey Safe and Secure Communities Program Grant # 23-1612 for the period of 01/25/2023 to 01/24/2024; and

WHEREAS, the Mayor and Council of the Borough of Totowa has reviewed the accompanying application and has approved said request; and

WHEREAS, the project is a joint effort between the New Jersey Department of Law and Public Safety, Office of the Attorney General and the Borough of Totowa, for the purpose described in the application.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Totowa that:

- 1) As a matter of public policy, the Mayor and Council of the Borough of Totowa wishes to participate to the fullest extent possible with the New Jersey Department of Law and Public Safety, Office of the Attorney General and to accept the grant funding in the amount of \$32,400.
- 2) The New Jersey Department of Law and Public Safety, Office of the Attorney General shall receive funds on behalf of the applicant.
- 3) The New Jersey Department of Law and Public Safety, Office of the Attorney General shall be responsible for the receipt and review of the applications for said funds.
- 4) The New Jersey Department of Law and Public Safety, Office of the Attorney General shall initiate allocations to the applicant as authorized by law.

WHEREAS, the Borough of Totowa Police Chief has requested that two new police vehicles be purchased and added to the Borough of Totowa fleet; and

WHEREAS, more specifically, the Police Chief has requested the purchase of two Chevrolet Tahoe Patrol Vehicles; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that there is a need for two new police vehicles in order to maintain and keep the fleet updated; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize the purchase of these vehicles; and

WHEREAS, State of New Jersey Contract No. 21-Fleet-01485 has been awarded to Gentilini Motors, 2703 Fire Road, Egg Harbor Township, New Jersey 08234 for the purchase and delivery of Chevrolet Tahoe Patrol Vehicles and all related equipment; and

WHEREAS, pursuant to the applicable New Jersey State laws, the purchase of the police vehicles may be authorized without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the purchase of two 2022/2023 Chevrolet Tahoe Patrol Vehicles from Gentilini Motors in the amount of \$53,278.04 per Patrol Vehicle for a total cost of \$106,556.08.

BE IT FURTHER RESOLVED, that the Mayor and Municipal Council of the Borough of Totowa do hereby authorize the Municipal Clerk and Police Chief to execute any and all instruments relating thereto.

WHEREAS, the Mayor and Council of the Borough of Totowa desire to retain the services of a professional engineering firm to provide design services, prepare bid documents, assist in the bidding process and supervise construction of the 2023 New Jersey Department of Transportation ("NJDOT") Municipal Aid Road Program; and

WHEREAS, the 2023 NJDOT Road Program calls for improvements to sections of Winifred Drive, Liberty Ridge Trail and Centennial Court; and

WHEREAS, the project will consist of roadway subbase repair, the milling and resurfacing of the roadways, the adjustment of castings, the installation of ADA compliant curb ramps, the installation of crosswalks, the installation of Stop Signs and Stop bars and replacing pavement markings; and

WHEREAS, Alaimo Group has submitted a proposal dated December 12, 2022 to provide the design, bid assistance and construction supervision services for the roads selected at a cost not to exceed \$110,700.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, the Mayor and Council of the Borough of Totowa on February 14, 2023 did examine the proposal submitted by Alaimo Group; and

WHEREAS, pursuant to the applicable New Jersey State laws, these professional services may be awarded without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by Alaimo Group for professional engineering services for the 2023 NJDOT Municipal Aid Road Program in the amount of \$110,700.00.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize Alaimo Group to perform the professional services as set forth in their proposal.

There was a motion by Councilman Capo, seconded by Councilwoman Andriani to approve the request. On roll call vote, all members of the Council present voted in the affirmative.

#### STREET CLOSING AUTHORIZED BY THE MAYOR

Under the authority vested in me as Mayor of the Borough of Totowa, County of Passaic, State of New Jersey, by virtue of N.J.S.A. 40:67-16.9 and the Code of the Borough of Totowa Chapter No. 398-42, I, Mayor John Coiro, do hereby order and direct that Rosengren Avenue between Totowa Road and Union Boulevard be closed to vehicular traffic on Thursday, March 16, 2023 and Friday, March 17, 2023. I further direct that proper signs and barriers be erected at the

intersections of Rosengren Avenue and Totowa Road and Rosengren Avenue and Union Boulevard and that the Totowa Police Department control and regulate, as well as enforce, this regulation.

BE IT FURTHER RESOLVED, the Mayor and Council of the Borough of Totowa agrees that if CDBG funds are determined by the US Department of Housing and Urban Development to be expended on ineligible program costs or do not meet a national objective, the Borough of Totowa agrees to repay the proportion deemed ineligible from non-federal sources.

# RESOLUTION NO. 41-2023

RESOLUTION IN SUPPORT OF THE FEDERAL FAIR HOUSING LAW AND NEW JERSEY LAW AGAINST DISCRIMINATION

WHEREAS, the Borough of Totowa supports Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the New Jersey Law Against Discrimination; and

WHEREAS, it is the policy of the Borough of Totowa to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, ancestry, sex (including pregnancy), national origin, nationality, familial status, marital or domestic partnership status, affectional or sexual orientation, atypical hereditary cellular or blood trait, genetic information, liability for military service, mental or physical disability, perceived disability, AIDS/HIV status and Lawful Income or Source of Lawful Rent Payment (Section 8); and

WHEREAS, the Borough of Totowa further objects to discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, ancestry, sex, national origin, handicap or disability as prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the New Jersey Law Against Discrimination.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby support Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the New Jersey Law Against Discrimination as follows:

- 1. Within available resources, the Borough of Totowa will assist all persons who feel they have been discriminated against under one of the aforementioned categories, to seek equity under federal and state laws by filing a complaint with the New Jersey Division on Civil Rights and the U.S. Department of Housing and Urban Development, as appropriate.
- 2. The Borough of Totowa shall publicize this resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law, the New Jersey Law Against Discrimination, and any local laws or ordinances.
- 3. The Borough of Totowa will at a minimum include, but not be limited to: (1) the printing and publicizing of this resolution, a fair housing public notice and other applicable fair housing information through local media, community contacts and placement on the Municipal website and in other social media; (2) distribution of posters, flyers, and any other means which will bring to the attention of those affected, the knowledge of their respective responsibilities and rights concerning equal opportunity in housing.

A letter was received from the Totowa Public Library Foundation requesting permission to use the Municipal Parking Lot for their Irish Dinner To Go Fundraiser on Monday, March 13, 2023. There was a motion by Councilman Capo, seconded by Councilwoman Andriani to grant permission. On roll call vote, all members of the Council present voted in the affirmative.

There was a motion by Councilman Capo, seconded by Councilwoman Andriani to grant permission. On roll call vote, all members of the Council present voted in the affirmative.
