# MINUTES OF THE MAYOR AND COUNCIL

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

WHEREAS, by Resolution No. 120-2022 dated October 22, 2022, the Mayor and Council of the Borough of Totowa authorized the purchase of a new Pierce Custom Chassis Pumper Fire Truck from Fire & Safety Services, Ltd. to be added to the Borough of Totowa Volunteer Fire Department fleet; and

WHEREAS, more specifically, the new Pierce Custom Chassis Pumper Fire Truck will be assigned to Riverview Park Fire Company #3 and identified as New Engine 973; and

WHEREAS, Riverview Park Fire Company #3 has received notification that the construction of New Engine 973 is almost complete; and

WHEREAS, the process to build the apparatus has taken several years because the new Fire Truck is customized to meet the specific needs of the Borough of Totowa community; and

WHEREAS, at the time the new Pierce Custom Chassis Pumper Fire Truck was ordered, the members of Riverview Park Fire Company #3 believed they could use the existing Fire Hose from the Fire Company's older Fire Truck that is being replaced; and

WHEREAS, due to passage of time, the Fire Hose has deteriorated and can no longer reliably be utilized; and

WHEREAS, the Borough of Totowa Fire Chief has recommended the purchase of new Snap-Tite Fire Hose for New Engine 973 which is the same brand currently being used for the Borough of Totowa Volunteer Fire Department fleet; and

WHEREAS, the Borough of Totowa Fire Chief solicited quotes from authorized vendors of Snap-Tite Fire Hoses; and

WHEREAS, Fire & Safety Services, Ltd., 200 Ryan Street, South Plainfield, New Jerey 07080 has submitted a proposal dated November 13 2025 for the purchase and delivery of new Snap-Tite Fire Hose and related accessories in the amount of \$26,526.10, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, Fire & Safety Services, Ltd. has advised that it will provide delivery of the new Fire Hose within 6 to 8 weeks with all other manufacturers of the equivalent of the Snap-Tite Fire Hose have advised that it would take 8 to 12 months to provide the new Fire Hose; and

WHEREAS, the delivery of the Snap-Tite Fire Hose will coincide with the delivery of the New Engine 973; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize the purchase and delivery of the new Snap-Tite Fire Hose for the Borough of Totowa Volunteer Fire Department for the protection of life and property of the residents of the Borough of Totowa.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the Borough of Totowa to purchase new Snap-Tite Fire Hose for New Engine 973 in the amount of \$26,526.10.

WHEREAS, 454 Mechanical, LLC, 14 Masklee Court, Totowa, New Jersey 07512 has submitted a proposal dated November 10, 2025 to remove and replace the zone valve for the main hall area as well as to assess various boiler violations for the sum of \$2,765.25, a copy of which is on file in the office of Borough of Totowa Municipal Clerk; and

WHEREAS, the proposal includes bleeding and purging the system, starting and testing the system and includes all necessary labor and materials needed to complete the boiler repairs; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to have the boiler repairs undertaken and completed as soon as possible for the well-being and safety of the Borough of Totowa Lincoln Fire Company Volunteer Firefighters; and

WHEREAS, pursuant to the applicable New Jersey State laws, the repair services may be authorized without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by 454 Mechanical, LLC for the heating and boiler repairs at the Borough of Totowa Lincoln Fire House.

BE IT FURTHER RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize 454 Mechanical, LLC to perform all services for the heating and boiler repairs at the Borough of Totowa Lincoln Fire House in accordance with their proposal.

# RESOLUTION AUTHORIZING THE BOROUGH OF TOTOWA TO ENTER INTO A DEVELOPER'S AGREEMENT WITH SHEPHERDS LANE COMMONS LLC

WHEREAS, G.O.M. Real Estate Investment, LLC was the owner of real property set forth and designated as Block 11, Lot 9.01 on the official Tax and Assessment Map of the Borough of Totowa and commonly known as 95 Shepherds Lane, Totowa, New Jersey 07512; and

WHEREAS, the property is located in the R-AH-2 Affordable Housing-2 Zone District; and

WHEREAS, G.O.M. Real Estate Investment, LLC filed an application with the Borough of Totowa Planning Board for various land use approvals seeking preliminary and final major site plan approval with variance relief for the Shepherds Lane property for the construction of 2 buildings containing a total of 74 units for rent; and

WHEREAS, 59 of the units will be market rate and 15 of the units will be affordable housing; and

WHEREAS, the Borough of Totowa Planning Board at its public meeting held on July 9, 2020 granted preliminary and final site plan approval and various land use relief for the application filed by G.O.M. Real Estate Investment, LLC for the Shepherds Lane property, subject to certain conditions and restrictions; and

WHEREAS, the Borough of Totowa Planning Board approved the application on July 9, 2020 and memorialized its decision in a Resolution adopted by the Planning Board on August 13, 2020; and

WHEREAS, Shepherds Lane Commons LLC is the successor to G.O.M. Real Estate Investment, LLC; and

WHEREAS, Shepherds Lane Commons LLC filed an amended application with the Borough of Totowa Planning Board seeking amended preliminary and final major site plan approval with variance "c" relief including track setback, building length, height and parking lot relief; and

WHEREAS, the Borough of Totowa Planning Board at its public meeting held on April 11, 2024 granted the preliminary and final site plan approval and various land use relief for the application filed by Shepherds Lane Commons LLC for the Shepherds Lane property, subject to certain conditions and restrictions; and

RESOLUTION AUTHORIZING THE PROVISION OF A GRANT PURSUANT TO THE BOROUGH OF TOTOWA AFFORDABILITY ASSISTANCE PROGRAM FOR THE TENANT OF AN AFFORDABLE HOUSING UNIT LOCATED AT SUNSET RIDGE AT TOTOWA, 617 PREAKNESS AVENUE, APARTMENT 106

WHEREAS, Applicant, Alfred Ng ("Tenant") will be renting Apartment 106, Sunset Ridge at Totowa, 617 Preakness Avenue, Totowa, New Jersey 07512 ("Unit"), a property governed by the statutes, ordinances, rules and regulations restricting occupancy and use of the property as an affordable housing unit; and

WHEREAS, the Tenant is eligible for an Affordability Assistance Grant through the Borough of Totowa's Affordability Assistance Program to pay for four month's rent for the Unit; and

WHEREAS, the Borough of Totowa's Affordable Housing Administrative Agent, Community Grants, Planning & Housing, LLC, ("CGP&H") has reviewed the Tenant's application and qualified the Tenant for the requested assistance; and

WHEREAS, the amount of the requested grant for the four month's rent will be paid directly to the Landlord, (\$540.00) by the Borough of Totowa; and

WHEREAS, the Borough of Totowa is willing, pursuant to the Affordability Assistance Program, to extend a grant in the amount of \$540.00; and

WHEREAS, the funding for the grant will be from the Borough of Totowa Affordable Housing Trust Fund.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa does hereby authorize the following:

1. The Borough of Totowa is hereby authorized, pursuant to the Borough of Totowa's Affordability Assistance Program, to provide the Tenant with a grant to be used to pay four month's rent for the Unit.

2. The Mayor, Municipal Clerk, Borough Attorney, CFO and such other staff and officials as may be appropriate are authorized to take such steps as may reasonably be required to implement this resolution, including issuance of the grant amount.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.
