# MINUTES OF THE MAYOR AND COUNCIL

# May 9, 2023

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

Municipal Clerk Wassel read the following statement: This meeting of the Mayor and Council held on this day is being held in accordance with Chapter 231, P.L. 1975 of the State of New Jersey as amended. The agenda for this meeting has been prepared and distributed to the Mayor and Council and a copy has been on file in the Office of the Municipal Clerk.

There was a motion by Councilman D'Angelo, seconded by Councilman Picarelli to dispense with the regular order of business in order to enable the Mayor and Council to present Sports Award Certificates to the 2023 Totowa PAL 3<sup>rd</sup> & 4<sup>th</sup> Grade Passaic Valley Youth Basketball League champions, to hold a public hearing on the 2023 Municipal Budget and to hold a public hearing on Ordinance No. 06-2023 as advertised. On roll call vote, all members of the Council present voted in the affirmative.

Mayor Coiro remarked that it is always a fun night for us to celebrate our youth and congratulated all the basketball players and coaches on winning the championship and mentioned how it is great that they are involved in team sports as it teaches you about teamwork, hard work and dedication.

Mayor Coiro began by calling up Coach Chad and Coach Chela and presented each with a Sports Award Certificate. Coach Chad thanked the Mayor and Council, Senator Kristin Corrado and Borough Clerk Wassel for honoring the team. Coach Chad gave a recap of their season and of the championship game. ### RESOLUTION NO. 58-2023

# RESOLUTION REGARDING SELF-EXAMINATION OF THE 2023 MUNICIPAL BUDGET

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 thru 7.5 the Borough of Totowa has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Borough meets the necessary conditions to participate in the program for the 2023 budget year.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Totowa that in accordance with N.J.A.C. 5:30-7.6a & b and based upon the Chief Financial Officer's certification, the Governing Body has found the budget has met the following requirements:

- 1. That with reference to the following items, if applicable, the amounts have been calculated pursuant to law and appropriated as such in the budget.
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with the "CAP" law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate, and correctly stated.
  - b. Items of appropriations are properly set forth
  - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Director of the Division of Local Government Services.

There was a motion by Councilman D'Angelo, seconded by Councilman Picarelli to approve Resolution No. 59-2023 To Adopt The 2023 Municipal Budget. On roll call vote, all members of the Council present voted in the affirmative.

Municipal Clerk Wassel read the legal notice and the title of Ordinance No. 06-2023.

WHEREAS, on March 30, 2023, Crestview Motel, Inc. submitted the renewal application and paid the appropriate State and Municipal fees; and

WHEREAS, on April 6, 2023, the Director of the Division of Alcoholic Beverage Control did grant relief pursuant to N.J.S.A. 33:1-12.18 for Crestview Motel, Inc.; and

WHEREAS, on May 9, 2023, the Borough of Totowa did receive a Tax Clearance Certificate for Crestview Motel, Inc.
