Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

There was a motion by Councilman D'Angelo, seconded by Councilman Picarelli to revert to the regular order of business. On roll call vote, all members of the Council present voted in the affirmative.

Mayor Coiro asked if any members of the Council, the Municipal Clerk or the Municipal Attorney wished to address the Council.

RESOLUTION NO. 95-2025

RESOLUTION APPROVING CHANGE ORDER NO. 3 AND AUTHORIZING AN AMENDMENT TO THE CONTRACT FOR THE FY2024 NEW JERSEY DEPARTMENT OF TRANSPORTATION MUNICIPAL AID AND 2024 ROAD PROGRAM

WHEREAS, the Municipal Engineer for the Borough of Totowa had recommended improvements to streets throughout the municipality including sections of Battle Ridge Trail, Columbus Avenue, Vita Road and Willow Court as part of the FY2024 New Jersey Department of Transportation ("NJDOT") Municipal Aid Road Program and 2024 Road Program; and

WHEREAS, the project consisted of roadway subbase repair, the milling and resurfacing of the roadways, the installation of ADA compliant curb ramps, the installation of Stop Signs and Stop bars and replacing pavement markings; and

WHEREAS, by Resolution No. 60-2024 dated April 23, 2024, the Mayor and Council of the Borough of Totowa authorized the Borough of Totowa Municipal Engineer, Richard A. Alaimo Engineering Associates, to provide design services, prepare bid documents, assist in the bidding process and supervise construction of the FY2024 NJDOT Municipal Aid and 2024 Road Program; and

WHEREAS, the Mayor and Council of the Borough of Totowa did advertise for receipt of sealed bids in accordance with the specifications entitled "Borough of Totowa, FY2024 NJDOT Municipal Aid and 2024 Road Program, Contract No. 2024-1"; and

WHEREAS, by Resolution No. 109-2024 dated August 13, 2024, Mayor and Council of the Borough of Totowa authorized a contract to AJM Contractors, Inc., 300 Kuller Road, Clifton, New Jersey 07011 for the FY2024 NJDOT Municipal Aid and 2024 Road Program for the total sum of \$484,130.50; and

WHEREAS, the Municipal Engineer has advised that there was a discrepancy in the asphalt quantity on the plans due to the inadvertent omission of the tonnage of asphalt for one of the roadways included in the FY2024 NJDOT Municipal Aid and 2024 Road Program; and

WHEREAS, this discrepancy in the asphalt quantity did not surface until after the roads were paved and the contractor submitted for payment; and

WHEREAS, the contract for the FY2024 NJDOT Municipal Aid and 2024 Road Program was awarded as a per unit bid award and therefore, the discrepancy did not affect the determination of the lowest responsible bidder; and

WHEREAS, the asphalt installed along with field quantity adjustments resulted in an increase to the contract in the amount of \$51,771.26 and was presented to the Governing Body as Change Order No. 3 to the contract; and

WHEREAS, Change Order No. 1 and Change Order No. 2 to the contract totaling \$96,558.39 were previously submitted to the Governing Body and have already been approved; and

WHEREAS, the 3 Change Orders to the contract have resulted in an increase that now exceeds 20% of the original price and will require an amendment to the contract; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to pay the contractor for all work completed under the contract.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby approve Change Order No. 3 and authorize an amendment to the contract between the Borough of Totowa and AJM Contractors, Inc. for the Municipal Aid and 2024 Road Program.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.

There was a motion by Councilman Bucher, seconded by Councilman Fierro to approve Change Order No. 3 for a net increase of \$51,771.26 and Payment Estimate No. 3 (Final) in the amount of \$65,852.42 to AJM Contractors for the FY2024 NJDOT Municipal Aid and 2024 Road Program. On roll call vote, all members of the Council present voted in the affirmative.

Upon the recommendation of DPW Superintendent Jim Niland, there was a motion by Councilman Bucher, seconded by Councilman Fierro to approve a grade increase for DPW Laborer Michael Bastante from Grade 2 to Grade 1. On roll call vote, all members of the Council present voted in the affirmative.

Upon the recommendation of DPW Superintendent Jim Niland, there was a motion by Councilman Bucher, seconded by Councilman Fierro to approve a grade increase for DPW Laborer Brian Henderson from Grade 5 to Grade 4. On roll call vote, all members of the Council present voted in the affirmative.

There was a motion by Councilman Fierro, seconded by Councilman Reynoso to adopt the following Resolution Authorizing The Replacement Of The Roof At Riverview Pump Station. On roll call vote, all members of the Council present voted in the affirmative.

RESOLUTION NO. 96-2025

RESOLUTION AUTHORIZING THE REPLACEMENT OF THE ROOF AT RIVERVIEW PUMP STATION

WHEREAS, the Borough of Totowa Department of Public Works ("DPW") Superintendent has advised that the roof at the Riverview Pump Station has deteriorated and has recommended that the roof be removed and replaced; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that there is a need for the removal and replacement of this roof; and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize the replacement of the roof at the Riverview Pump Station; and

WHEREAS, Jemmco LLC, 15 Artillery Road, Totowa, New Jersey 07512 has submitted a proposal dated June 16, 2025 for the removal and replacement of the roof at the Riverview Pump Station in the amount of \$6,200.00, a copy of which is on file in the office of the Borough of Totowa Municipal Clerk; and

WHEREAS, the work to be performed includes, but is not limited to, cleaning the roof of all debris; mechanically fastening ½" recovery board to the existing deck; installing fully adhered EPDM roofing on entire roof and porch area; installing form flashing on all roof penetrations; installing new drip edge and flash to new EPDM roof; installing water cut off and sealant; and installing new 6" gutter and 3" x 4" leader pipe to prevent water run off; and

WHEREAS, pursuant to the applicable New Jersey State laws, the removal and replacement of the roof at the Riverview Pump Station may be authorized without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the replacement of the roof at Riverview Pump Station by Jemmco LLC in the amount of \$6,200.00.

BE IT FURTHER RESOLVED, that the Mayor and Municipal Council of the Borough of Totowa do hereby authorize the Municipal Clerk and DPW Superintendent to execute any and all instruments relating thereto.

WHEREAS, JGN Massage, LLC doing business as Elements Therapeutic Massage ("Elements Therapeutic Massage") has approval to operate a massage establishment in a portion of the premises located at 650 Union Boulevard, Totowa, New Jersey; and

WHEREAS, in accordance with the requirements set forth in Chapter 250 entitled "Massage Establishments" in the Borough of Totowa Code Book, Elements Therapeutic Massage has submitted an application to the Borough of Totowa for a Massage Establishment License; and

RESOLUTION AUTHORIZING THE RENEWAL OF DIVISION OF ALCOHOLIC BEVERAGE CONTROL LIQUOR LICENSE NUMBER 1612-33-002-005 FOR THE 2024 – 2025 LICENSE TERM

WHEREAS, Division of Alcoholic Beverage Control (ABC) liquor licenses that have been issued by the Borough of Totowa during the 2023 – 2024 license term expired on June 30, 2024; and

WHEREAS, State and Municipal regulations require that ABC liquor licenses be renewed prior to July 1, 2024; and

WHEREAS, state regulations further requires that all licensees must have filed their renewal applications online through POSSE ABC, have received their Alcoholic Beverage Retail Licensee Clearance Certificate and have paid their State and Municipal fees prior to renewing any liquor license; and

WHEREAS, The 46 Lounge, LLC license number 1612-33-002-005 timely filed the renewal application and paid the State and Municipal fees, but the licensee did not receive a Tax Clearance Certificate prior to June 25, 2024 which was the last Council Meeting before the June 30, 2024 expiration date; and

WHEREAS, on December 9, 2024, The 46 Lounge, LLC did receive a Tax Clearance Certificate, but never informed the Borough of Totowa, so their license was never renewed for the 2024 – 2025 license term.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Totowa that the Municipal Clerk be authorized to renew the ABC Plenary Retail Consumption License For 2024 – 2025 License Term to The 46 Lounge, LLC license number 1612-33-002-005 and that the Municipal Clerk upload a copy of this resolution and complete the renewal process on the POSSE ABC website.
