MINUTES OF THE MAYOR AND COUNCIL

January 24, 2012

PRESENT: Mayor John Coiro, presiding, Councilman John Waryas, Councilman Jim Niland, Councilman Lou D'Angelo, Councilwoman Carolyn Fontanella, Councilwoman Debra Andriani, Municipal Clerk Joseph Wassel and Municipal Attorney Robert Corrado.

ABSENT: Council President Phil Puglise.

Mayor John Coiro called the meeting to order and asked the Municipal Clerk to call the roll.

Municipal Clerk Wassel recited the Prayer of the Meeting followed with the Pledge of Allegiance to the Flag with the public participating.

Mayor Coiro asked the Clerk to read the statement of the meeting.

The Municipal Clerk read the following statement: This meeting of the Mayor and Council held on this day is being held in accordance with Chapter 231, P.L. 1975 of the State of New Jersey as amended. The agenda for this meeting has been prepared and distributed to the Mayor and Council and a copy has been on file in the Office of the Municipal Clerk.

There was a motion by Councilman Waryas, seconded by Councilman Niland to dispense with the regular order of business in order to hold a public hearing on Ordinance No. 01-2012 as advertised. On roll call vote, all members of the Council present voted in the affirmative.

Municipal Clerk Wassel announced that Ordinance No. 01-2012 has been advertised for public hearing for Tuesday, January 24, 2012.

Municipal Clerk Wassel read the legal notice and the title of Ordinance No. 01-2012.

There was a motion by Councilman Waryas, seconded by Councilman Niland to open the public hearing. On roll call vote, all members of the Council present voted in the affirmative.

Mayor Coiro asked if any citizens wished to be heard on Ordinance No. 01-2012.

There was a motion by Councilman Waryas, seconded by Councilman Niland to adopt Ordinance No. 01-2012 on second and final reading. On roll call vote, all members of the Council present voted in the affirmative.

Mayor Coiro: 1) Advised that he met with our new Congressman Rodney Frelinghuysen, who said he is anxious to meet us and serve the residents of the Borough of Totowa in 2013; 2) Mentioned that today he attended a ribbon cutting at Spiral Binding where they installed 35 solar panels to become more energy efficient and reduce their carbon footprint.

RESOLUTION AUTHORIZING AN ASSIGNMENT OF CONTRACT FOR THE COLLECTION AND TRANSPORTATION OF RECYCLABLE MATERIALS FOR THE BOROUGH OF TOTOWA

WHEREAS, by Resolution No. 101-2009 dated December 8, 2009, the Mayor and Council of the Borough of Totowa awarded a contract for collection and transportation services for residential and municipal recyclable materials to Marangi Waste Industries, Inc., 155 Michigan Avenue, Paterson, New Jersey 07503 for the total sum of Three Hundred Seventy-Three Thousand Six Hundred Twenty and 00/100 Dollars (\$373,620.00); and

WHEREAS, the term of the contract was for the period of January 1, 2010 through December 31, 2014; and

WHEREAS, the Mayor and Council of the Borough of Totowa have received notice that Gaeta Recycling Co., Inc. has entered into a contract dated December 19, 2011 to purchase the various assets of Marangi Waste Industries, Inc.; and

WHEREAS, the purchase contract has been forwarded to the New Jersey Department of Environmental Protection for approval along with a management agreement which is intended to allow Gaeta Recycling Co., Inc. to collect the recyclables on behalf of Marangi Waste Industries, Inc. pending approval of the actual sale; and

WHEREAS, the governing body of the Borough of Totowa must agree to and approve any assignment of this contract; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that there is an ongoing need to continue to provide these services for the residents of the Borough of Totowa.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the assignment of the aforementioned contract from Marangi Waste Industries, Inc. to Gaeta Recycling Co., Inc. for the collection and transportation of recyclable materials subject to all terms and provisions set forth in the original contract.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.

RESOLUTION AUTHORIZING THE EMERGENCY PURCHASE AND INSTALLATION
OF THE BOILER REPLACEMENT FOR THE MUNICIPAL COMPLEX

WHEREAS, the existing heating equipment located in the Borough of Totowa Municipal Complex is no longer operable and needs to be replaced; and

WHEREAS, this situation adversely affects the public health, safety and welfare of the Borough of Totowa employees that work in this building as well as the members of the public that use the Borough services offered at the Municipal Complex; and

WHEREAS, the Borough of Totowa solicited proposals from licensed professional mechanical contractors to provide all necessary equipment, labor, tools and services for the emergency purchase and installation of two (2) hot water boilers at Borough of Totowa Municipal Complex; and

WHEREAS, the lowest responsible bid was submitted by CJ Vanderbeck & Son, Inc., 240 Marshall Street, Paterson, New Jersey 07503 for two (2) Raypack Hot Water Boilers Model MVB H7-504 or approved equivalent or higher efficiency units in the amount of Fifty-Two Thousand One Hundred Twenty and 00/100 Dollars (\$52,120.00); and

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize the purchase and installation of these hot water boilers at the Municipal Complex for the general health, safety and well-being of the Borough of Totowa employees and members of the public that use the Borough services offered at the Municipal Complex; and

WHEREAS, pursuant to the applicable N.J.S.A. 40A:11-5(1)(i), this emergency purchase and installation of two (2) hot water boilers constitutes an extraordinary unspecifiable service and this service may be authorized by the Borough of Totowa without public bidding.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby accept the proposal submitted by CJ Vanderbeck & Son, Inc., 240 Marshall Street, Paterson, New Jersey 07503 for two (2) Raypack Hot Water Boilers Model MVB H7-504 or approved equivalent or higher efficiency units in the amount of Fifty-Two Thousand One Hundred Twenty and 00/100 Dollars (\$52,120.00).

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.

**RESOLUTION AUTHORIZING A SETTLEMENT AGREEMENT WITH

WHEREAS, by Resolution No. 98-2011 dated November 15, 2011, the governing body of the Borough of Totowa denied the renewal of inactive Plenary Retail Consumption License No. License No. 1612-33-008-006 for the 2011-2012 and 2012-2013 License Terms on behalf of IDP Associates, Inc. (formerly Hickory Hill Garden Country Club, Inc.); and

WHEREAS, in January of 2012, IDP Associates, Inc. appealed to the New Jersey Division of Alcoholic Beverage Control ("ABC") for reversal of the denial of their application for renewal of the liquor license for the 2011-2012 and 2012-2013 license terms by the Borough of Totowa; and

WHEREAS, the IDP Associates, Inc. and the Borough of Totowa have reached a settlement concerning the aforementioned liquor license; and

WHEREAS, the terms of the settlement are as follows:

1. IDP Associates, Inc. will voluntarily dismiss its Petition of Appeal of the Borough of Totowa's denial to renew inactive Plenary Retail Consumption License No. License No. 1612-33-008-006 for the 2011-2012 and 2012-2013 license terms;
2. The Borough of Totowa agrees to renew the subject license for the 2011-2012 term;

3. If IDP Associates, Inc. does not sell the subject license before June 30, 2012, it will not seek a Special Ruling or otherwise file for a renewal of the subject license for the 2012-2013 license term and will therefore permit the license to lapse, except that;
4. If IDP Associates, Inc. has entered into a contract to sell the license before June 30, 2012, the Borough of Totowa will renew the license for the next term sought by either IDP Associates, Inc. or the contract purchaser.

WHEREAS, the Mayor and Council of the Borough of Totowa desire to authorize this settlement in the interest of amicably resolving this matter.

NOW, THEREFORE, BE IT RESOVED, that the Mayor and Council of the Borough do hereby authorize the aforementioned settlement agreement between the IDP Associates, Inc. and the Borough of Totowa.

WHEREAS, by Resolution No. 32-2012 dated January 24, 2012, the Mayor and Council of the Borough of Totowa authorized the settlement agreement between IDP Associates, Inc. and the Borough of Totowa; and

WHEREAS, pursuant to the terms of the settlement agreement, the Mayor and Council of the Borough of Totowa have agreed to renew Plenary Retail Consumption License No. License No. 1612-33-008-006 for the 2011-2012 term subject to the following conditions:

1. If IDP Associates, Inc. does not sell the subject license before June 30, 2012, it will not seek a Special Ruling or otherwise file for a renewal of the subject license for the 2012-2013 license term and will therefore permit the license to lapse, except that;
2. If IDP Associates, Inc. has entered into a contract to sell the license before June 30, 2012 the Borough of Totowa will renew the license for the next term sought by either IDP Associates, Inc. or the contract purchaser.

WHEREAS, the Mayor and Council of the Borough of Totowa after due and diligent consideration has determined that the request for renewal should be granted for the 2011-2012 term subject to the above conditions.

WHEREAS, diseases of the heart are the nation's leading cause of death and stroke is the fourth leading cause of death; and

WHEREAS, cardiovascular disease claims the lives of nearly 420,000 American females each year, approximately one death per minute; and

WHEREAS, each year, nearly 52% of all deaths due to cardiovascular disease and 60% of stroke deaths occur in females; and

WHEREAS, too many women die each year because they are unaware that heart disease is their No. 1 killer; and

WHEREAS, in 2008, the direct and indirect cost of cardiovascular disease in the U.S., including stroke, was nearly \$298 billion; and

WHEREAS, nearly as many women die of heart disease, stroke, and all other cardiovascular diseases than the next four causes of death combined, including all cancers; and

WHEREAS, only 16% of women surveyed in 2009 identified cardiovascular disease as the greatest health problem facing them; and

WHEREAS, February is designated as American Heart Month; and

WHEREAS, Go Red For Women is the American Heart Association's national call to increase awareness about heart disease—the leading cause of death for women—and to inspire women to take charge of their heart health and reduce risk; and

WHEREAS, all women should learn their own personal risk for heart disease, using tools such as the American Heart Association's My Life Check, Go Red For Women Heart CheckUp, Go Red BetterU- and by talking to their healthcare provider; and

WHEREAS, taking action and making the right choices relating to proper nutrition, physical activity, and other healthy lifestyle choices are essential to living a heart healthy life; and

WHEREAS, by choosing to MAKE IT YOUR MISSION! you can save lives.
